#### MINUTES OF JUNE 2, 2020 MEETING OF THE WEST CORNWALL TOWNSHIP MUNICIPAL AUTHORITY

The following are the minutes of the meeting of West Cornwall Township Municipal Authority held at the West Cornwall Township building situate at 73 South Zinn's Mill Road, Quentin, Lebanon County, Pennsylvania, on Tuesday, June 2, 2020 at 6:00 p.m. The meeting was duly advertised as required by the applicable statutes of the Commonwealth of Pennsylvania.

Present at the meeting were James Shoemaker, Chairman; Robert Kolb, Joseph Foltz, Glenn Yanos, Keith Richmond, William Matthews, Authority Board Members; David Lloyd, West Cornwall Township Supervisor; Sean Frederick, Esq. of Barley Snyder; Jeffrey Steckbeck, P.E., Manager/Engineer; and Amy B. Leonard, Esq., Solicitor.

Sean Frederick, Esq. was in attendance to present documents for signature related to the conduit financing project between the Authority and Pleasant View Retirement Communities. Mr. Frederick noted that the Authority previously authorized financing up to an amount of \$67 million and adopted the necessary Resolution to proceed with the conduit financing. Mr. Frederick stated that the final amount of the financing will be approximately \$53 million. Closing is scheduled for June 11, 2020. The Authority members approved the execution of the documents by Chairman Mr. Shoemaker and Secretary Mr. Kolb.

A Motion was made and seconded to approve the meeting minutes from February 4, 2020 meeting of the West Cornwall Township Municipal Authority, with all voting in favor.

**Manager's / Engineer's Report** – The financial reports were reviewed by Mr. Steckbeck, including the Quentin and Stoberdale checking accounts and money market accounts for March, April, and May 2020, and directed to be attached to the minutes. A Motion was made and seconded to approve the financial reports, and all voted in favor.

Mr. Steckbeck discussed that the pump station is running well. He reported that he recently retained Patrick Brewer do some cleaning and repainting. He noted that I&I is down, and flows are lower overall. The Authority Members then discussed the possibility of installing a small roof to cover the electrical components of the pump station. They also expressed an interested in scheduling an on-site visit to the pump station to evaluate its condition.

Solicitor's Report - Attorney Leonard had no items to report.

The next meeting of the West Cornwall Township Municipal Authority is scheduled for August 4, 2020 at 6:00 p.m.
